



Annual Pet Care Agreement---Lange Kennels Inc., dba Four Paws Inn

This is an agreement between Lange Kennels Inc., dba Four Paws Inn (hereinafter called "*Four Paws*") and the pet owner/s or owner representative whose signature appears below (hereinafter called "owner").

1. Owner agrees to pay the rate for pet care provided in effect on the date the pet is checked into *Four Paws*. (Initial) _____
2. Owner further agrees to be financially responsible for any required treatment for fleas/ticks at time of individual evaluation or any time deemed necessary by the pet care provider. (Initial) _____
3. Owner further agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the period the pet is in the care of *Four Paws*. (Initial) _____
4. If pet becomes ill or injured, or if the state of the animal's health otherwise requires professional attention, *Four Paws*, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the animal and the expense thereof shall be paid by the owner. (Initial) _____
5. *Four Paws* shall exercise reasonable care for the pet delivered by the Owner to the pet care provider. Owner recognizes and accepts potential risks involved in activity such as playtime, daycare and general handling of pets in/out of kennels, play areas, grooming, etc. It is expressly agreed by owner and pet care provider that *Four Paw's* liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$400 per animal admitted. The owner further agrees to be solely responsible for any and all acts of behavior of said pet while it is in the care of the pet care provider, to include payment of costs for injury to staff or other animals or damage to facility caused by the pet. (Initial) _____
6. Owner specifically represents to *Four Paws* that, to Owner's knowledge, the pet has not been exposed to any contagious diseases with a thirty day period prior to check in. Owner further agrees to maintain currency of vaccinations as required by *Four Paws* policy. (See special note regarding immunizations). (Initial) _____
7. All charges incurred by Owner shall be payable upon pickup of pet. *Four Paws* shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from services provided by *Four Paws*. The Owner hereby agrees that in the event the charges are not paid when due in accordance with this contract, *Four Paws* may exercise its lien rights upon ten days written notice given by *Four Paws* to Owner by certified mail to address shown on contract. *Four Paws* and Owner specifically waives all statutory or legal rights to the contrary. (Initial) _____
8. Owner agrees to pay *Four Paws* a \$30 non-refundable (cancellation) fee in the event changes to or cancellations of any reservation/s are not made within two business days (48 hours). Owner further agrees to pay *Four Paws* late fees of \$40 for after-hours pick up/drop off. (Per management discretion, rates for holidays may be higher). (Initial) _____
9. While it is understood and agreed up on between *Four Paws* and the Owner that we will accept intact female dogs, there will be an extra \$10/day charge in addition to the regular boarding rate for female dogs that come into heat while boarding.
10. It is okay to use the Owner's pet's picture/s and/or videos, post on the website, social media page or in other promotions or advertising at *Four Paws*. (Initial) _____
11. By signing this Agreement and leaving a pet with *Four Paws*, Owner certifies to the accuracy of all information given about the pet. *Four Paws* reserves the right to deny admittance to Owner's pet for any reason at any time.

INDEMNIFICATION

THE OWNER OF THE DOG SHALL DEFEND, INDEMNIFY AND HOLD HARMLESS *FOUR PAWS* OF AND FROM ANY AND ALL CLAIMS AND CAUSES OF ACTION ASSERTED AGAINST *FOUR PAWS* FOR ANY AND ALL EXPENSES AND MONIES *FOUR PAWS* MAY BE COMPELLED TO PAY BY REASON OF ANY CLAIMS, DEMANDS, LAWSUITS OR JUDGEMENTS WHICH ARISE OUT OF OR ARE IN ANY WAY CONNECTED TO THE HANDLING, CARE AND BOARDING OF OWNER'S PET REGARDLESS OF WHETHER SUCH CLAIMS OR ACTIONS ARE FOUNDED IN WHOLE OR PART UPON THE ALLEGED NEGLIGENCE OF *FOUR PAWS*. THE PROVISIONS OF THE PARAGRAPH SHALL SURVIVE THE TERMINATION OF THIS AGREEMENT.

A Note to Owners Regarding Immunization Records---

Proof of an annual veterinarian examination of your pet's health and vaccination status is the minimal requirement of admission to board at *Four Paws*. A copy provided by your veterinarian will be placed in your client file each year and expire one year from the date of the exam or at time of first vaccination expirations whichever comes first.

Canine Vaccinations required/recommended:

Rabies* every 1 year or 3 years
DHLPP/DAPPV** every 1 year or 3 years
Bordetella* every 6 months or 1 year

Hepatitis, Adenovirus Type 2, Leptospirosis, Lyme, Canine Influenza----Per veterinarian recommendation for boarding/travel

**frequency based on vaccine utilized and veterinarian recommendation.*

***Distemper/parvo, parainfluenza frequency based on vaccine utilized and veterinarian recommendation.*

Feline Vaccinations required/recommended:

Rabies* every 1 year or 3 years
FVRCP** every 1 year or 3 years
FeLV, FIV test** per veterinarian recommendations for boarding/travel

**frequency based on vaccine utilized and veterinarian recommendation.*

***feline viral rhinotracheitis, calicivirus, panleukopenia frequency based on vaccine utilized and veterinarian recommendation*

*Four Paws will accept titers from a licensed veterinarian in lieu of vaccinations with documentation of sufficient antibodies present.
We will not accept home-administered vaccines, hand-written vaccines, vaccine sticker labels or handwritten immunization "booklets"
All vaccines must be administered by a licensed veterinarian.*

I have fully read and understand this agreement in its entirety. I fully understand that all terms and conditions of this Agreement shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and *Four Paws*.
